This site includes all the information and forms necessary to register for the exam. We strongly recommend you review/print the entire Insurance Licensing Candidate Handbook. When you get to their site:

- 1). Under the **HOW DO I?** section is an orange bar that says "Start by entering test sponsor". Click the orange "GO" button and then the U-Z tab. Scroll down till you see "Wisconsin Insurance". This will take you to the part of the site that covers Wisconsin Insurance Licensing.
- 2). It is VERY IMPORTANT that you explore everything on this entire section of the site.
- 3). We highly recommend that you download and/or print the Candidate Handbook as a reference and review it cover to cover.

APPLICATION FOR EXAM PROCEDURE INCLUDES FINGERPRINTING & CRIMINAL BACKGROUND CHECK

The Wisconsin Office of the Commissioner of Insurance (OCI) also requires a criminal background check and fingerprinting of candidates. Please refer to the Candidate Handbook for details (pages 1, 3 & 7) It is very important that you follow all of the instructions and meet all requirements in order to complete the exam process. NON RESIDENTS Nonresident Licensure. The procedures outlined above apply to resident licensing only.
